

VOTING INFORMATION

Montgomery County uses Vote Centers for both the elections and early voting. The Voting Center locations and voting hours are announced through public media and by the League of Women Voters (www.lwvmontcoin.org) well in advance of election dates.

VOTER REGISTRATION

Requirements

A person is eligible to vote if s/he

- is a U.S. citizen and a resident of Indiana
- will be at least 18 years of age on or before the next election
- not currently in prison (<u>Ex-offenders ARE eligible to register and to vote.</u>)
- have lived at your current address for a least 30 days before the next election




